## **AGENDA ITEMS**

The Board Chair welcomed the Board members including new Board members and attendees to the meeting and opened the meeting with an acknowledgement of country.

## 3.1. Nursing and Midwifery Update

The Director Nursing and Midwifery, NSLHD outlined the current operations of the Directorate and provided updates to the Board on the following:

The Director Nursing and Midwifery, NSLHD also provided an update to the Board on workforce issues including nursing vacancies across NSLHD. The Director Nursing and Midwifery, NSLHD highlighted a number of recruitment projects currently underway, including recruitment of nurses from overseas.

**Action:** Board to receive ongoing monthly reports on nursing vacancies and a report in April 2023 on the outcomes of the overseas nursing and midwifery recruitment project.

#### 3.2. ICT Update

The Chief Digital Health Officer, NSLHD provided an overview of the NSLHD Digital Health Strategy 2021 – 2026. An update was also provided on the progress of the NSLHD Digital Health Transformation Plan. This new plan will align the ICT function and vision with the priorities of the NSLHD Digital Health Strategy and NSLHD Strategic Plan 2022 – 2027.

The Board received an update on the Single-Digital Patient Record (SDPR) program. The SDPR will provide comprehensive, up-to-date medical records in a single system. This will empower and involve patients in their own care to support positive health outcomes. It will also improve workflow processes for clinical staff.

The Director Population and Planetary Health, NSLHD provided an overview of the NSLHD Population Health Plan 2022 – 2027.

The NSLHD Population Health Plan 2022 – 2027 aligns with the NSW Future Health: Strategic Framework 2022 – 2032 and the NSLHD Strategic Plan 2022 – 2027. The



Population Health Promotion unit is targeting the following focus areas for costeffective interventions:

- · Healthy eating and active living
- Smoking and vaping reduction
- Alcohol harm reduction
- Social wellbeing

The Director Population and Planetary Health, NSLHD and A/CE provided an update on the NSLHD Planetary Health program: the path to net zero by 2035.

The Board **resolved** to appoint a NSLHD Board member Dr Donna Lynch to the NSLHD Executive Planetary Health Committee. Minutes of those meetings are to continue to come to the Board. The Board requested that there be appropriate consumer representation on the Committee.

The Board **resolved** for the Population and Planetary Health directorate to provide quarterly reports to the NSLHD Board.

**Action:** The Terms of Reference for the NSLHD Planetary Health Committee to be updated for review and endorsement by the Board at the March 2023 meeting.

**Action:** A joint communiqué from the A/CE and Board Chair is to be sent to all staff on the current progress of the NSLHD Planetary Health program and its aims for 2023.

## 8.1. JMO Wellbeing Committee

The A/CE provided a verbal update on the JMO Wellbeing Committee with the following highlights:

- The NSLHD JMO Wellbeing Committee will meet every 3 months.
- The Director Medical Services at each facility will attend these meetings, with updates on the work underway at a facility level to be reported to the Executive Director Medical Services NSLHD.
- The Board Chair and the A/CE will issue a joint communiqué to relevant staff.

#### 9.1. Board Chair Report

The Board Chair provided a verbal update with the following highlights:

- The Board Chair attended a visit with the Deputy Board Chair and A/CE to the Brookvale Community Health Centre. Several matters arising from that visit are being attended to.
- The NSLHD Board Strategy Day will be held on 11 March 2023.
- The Board Chair and A/CE recently met with the Chief Executive Officer NORTH Foundation to discuss philanthropy opportunities and related matters.



- The Board Chair attended a Council of Board Chairs. The Board Chair tabled a copy of the "Remarkable Humans of NSW Health" document that will be given to all NSW Health staff. The Board Chair noted the importance to the Ministry of all local health districts managing their leave balances.
- The Northcare Foundation has generously agreed to fund a Senior Nurse Educator position for the next two years within ICU at RNSH. Members of the NSLHD Board and Northcare Foundation board will meet in early 2023 to discuss further opportunities for ICU at RNSH.
- The Board Chair met with Professor Bruce Robison AC, Chair of Research at NSLHD.
- NSLHD is exploring further partnership opportunities with UTS, Macquarie University and USYD.
- Mona Vale Hospital will undergo accreditation in June 2023.
- The Board Chair met with Aware Super to discuss key worker accommodation opportunities.

The NSLHD Board **resolved** to trial an arrangement that would see the next generation of NSLHD leaders in medicine, nursing and allied health being invited to attend board meetings (and possibly also board committee meetings) as observers, with the detail of the arrangement (including selection criteria and confidentiality requirements) to be determined by the Board Chair and the A/CE. The Board agree that the arrangement would be reviewed at the end of 12 months after its commencement.

**Action:** The Terms of Reference for the NSLHD Board Research, Innovation and Technology Committee are to be finalised for review and endorsement at the March 2023 meeting.

### 9.2. Chief Executive Report February 2023

- Philanthropy opportunities are currently being explored with the NORTH Foundation and the University of Sydney. These discussions are being facilitated by NSLHD.

- Discussions have commenced with stakeholders around research and precinct governance following the development and launch of the NSLHD St Leonards Health Campus Health, Research and Education Precinct Plan
- The NSLHD Executive attended the inaugural NSLHD Strategic Plan 2022

   2027 Governance Committee in early February to discuss delivery of the priorities outlined in the plan.
- NSLHD recently launched the NSLHD Network Charter. This outlines what
  the responsibilities of each hospital and Clinical Network. This document
  highlights the joint accountability of the Clinical Networks and hospitals in
  the services they deliver. NSLHD has also standardised the reporting of
  the Clinical Networks.



- The Deputy Secretary Patient Experience & System Performance Division met with the A/CE and other members of the NSLHD Executive and senior clinicians.
- The A/CE recently visited Dalwood Child Youth and Family Health, Brookvale Community Health Centre, Mona Vale Hospital and the Haematology department at RNSH.
- The Manly Adolescent and Young Adult Hospice opened successfully in February 2023, welcoming its first patients.
- The role of Director Performance Analytics NSLHD is currently being recruited to.
