#### 5. Professor Alexander Engel – ROBCO Presentation

Professor Alexander Engel, Director, Cancer Services, NSLHD, provided an overview of the Cancer Institute NSW's 2020 'Reporting for Better Cancer Outcomes' Performance

Report for NSLHD and its implications for future research governance and strategies. The Board noted recent discussions with the MoH on clinical variation and related matters relevant to cancer services and cancer research.

## 6. MoH Risk Presentation

The Director Corporate Governance and Risk Management (DGRM) and the Principal Policy Officer (PPO), Ministry of Health (MoH) presented the revised system-wide risk reporting approach. The NSLHD Board was advised that from January 2021 NSW Health organisations will no longer report their 'Top 10' risks to the MoH. The DGRM and PPO provided detail of the new proposed three-part approach for managing risk across the NSW Health system: part one, organisation-level risk management; part two potentially significant/emerging system-wide risk; part three, system-level risk statements. The Board noted that this presentation had also been made to the Board Audit and Risk Committee. The Board discussed the implications for the quarterly risk report that comes to the Board. The matter will be considered further by the Finance, Risk and Performance (FRAP) Committee at its next meeting. The Board had a brief discussion on climate change risk.

## 7. Professor Gin S Malhi

Professor Gin Malhi, Head Department of Psychiatry, RNSH presented his research and findings on depression and suicide in young women and their implications for resilience.
